WARRANTY

Avolites (UK) Ltd., ("Avolites or authorised dealer") warrants to the buyer ("the buyer") that all parts (except expendable items, including, but without limitation, faders, key switches, power supply, IC chips, DC to DC converters, trackball/trackball retainer ring, arm rest, CPU fan, case fan and UPS batteries), of every new lighting and media product, ("Equipment") purchased from Avolites (UK) Ltd, or an authorised Avolites or authorised dealer shall be free from defects in materials and workmanship for the period of:

- 12 months from the date of purchase (Essential Collection)
- 24 months from the date of purchase (Diamond Collection)

This warranty is given subject to the following terms:

To obtain the benefit of Warranty, the original or legible copy of the invoice or bill of sale or other date proof-of-purchase document describing the Equipment and its serial number, must be submitted to Avolites (UK) Ltd., ("Avolites or authorised dealer"). After warranty is confirmed Avolites or Avolites authorised dealer may, at its option, give other directions regarding repair or replacement of defective items.

Avolites or authorised distributors will, at its option under this Warranty, repair or replace any Equipment covered by this Warranty which becomes defective, malfunctions, or otherwise fails to conform with this Warranty under normal use and service during the term of this Warranty, at no charge. Any equipment repaired under this Warranty will itself be warranted only for the remainder of the Warranty period of the original Equipment repaired or replaced. The shipping of the product for repair or new parts is not covered by the warranty.

This Warranty does not cover defects, malfunctions or failures resulting from delivery or transit, accidents, wilful damage, negligence, abuse, misuse, operation contrary to furnished instructions, operation on incorrect power supplies, operation with faulty associated equipment, modification, alterations, improper servicing, tampering or unauthorised repair.

This Warranty gives the buyer specific legal rights. The buyer may also have other express or implied rights in addition to this Warranty. This depends upon the applicable law of the country or state where delivery took place and whether the buyer purchased the Equipment during a business. Transfer of ownership will require the product to be re-registered to re-validate the warranty. Re-validating the warranty will remain valid from date of original purchase.
